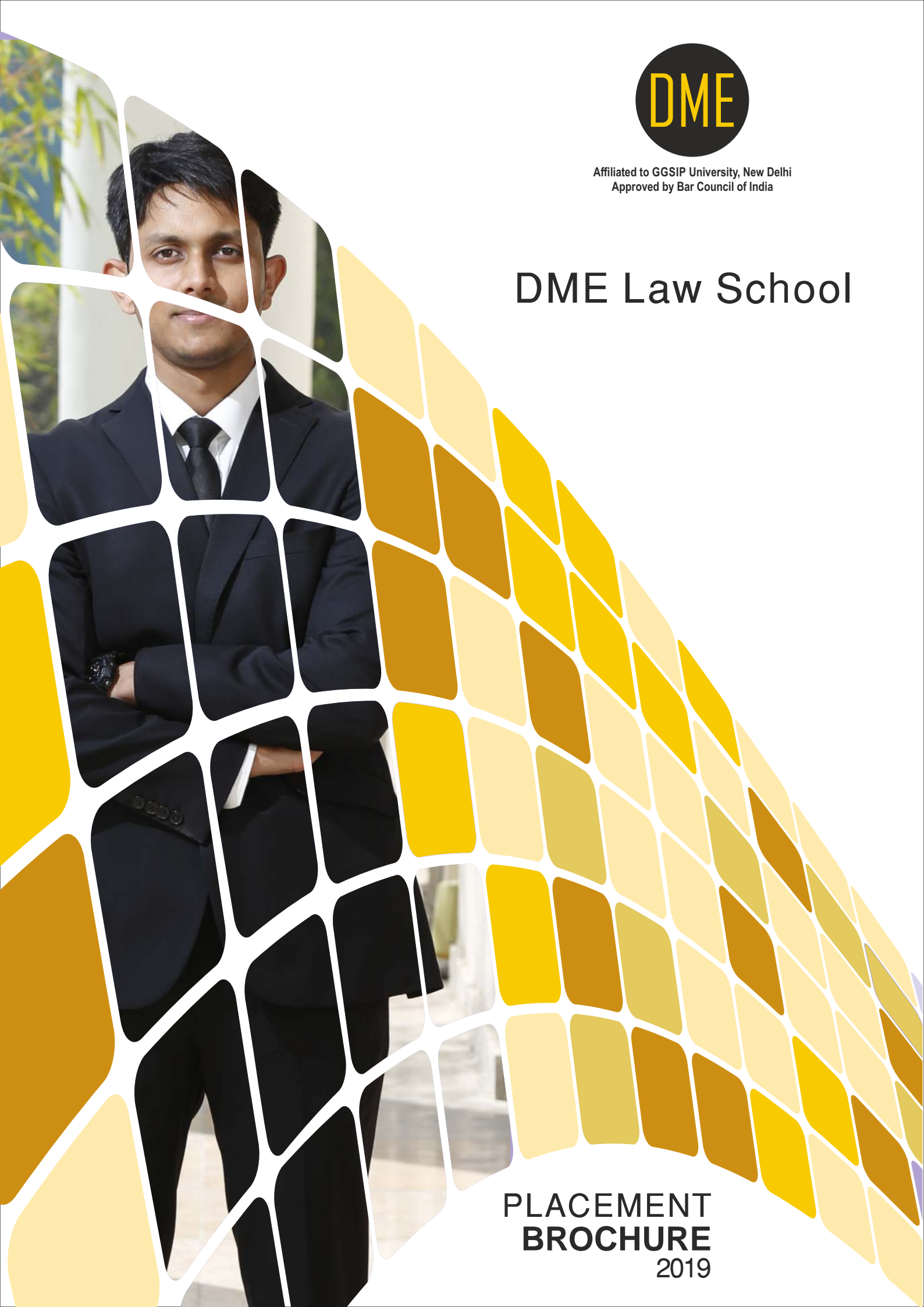


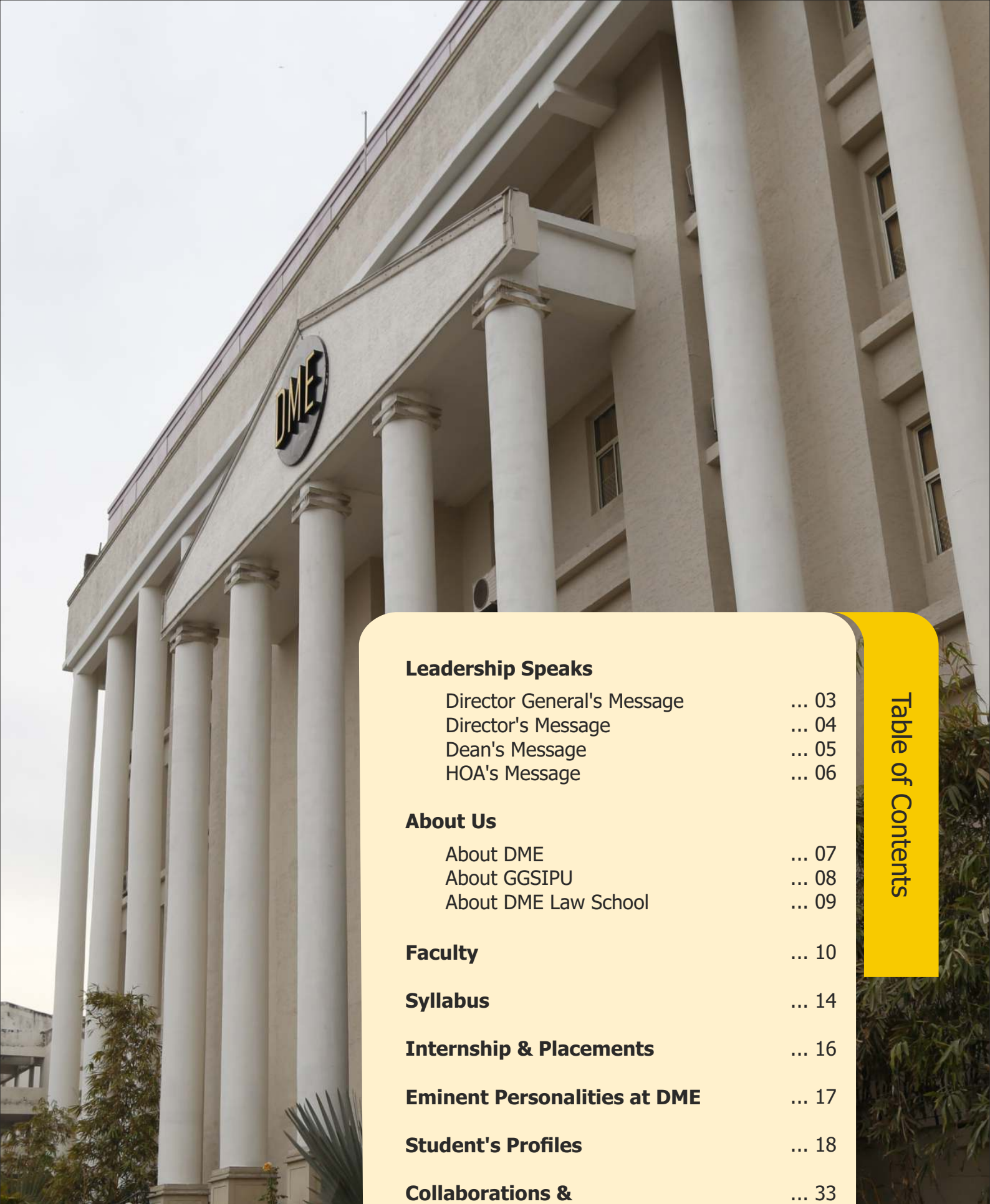

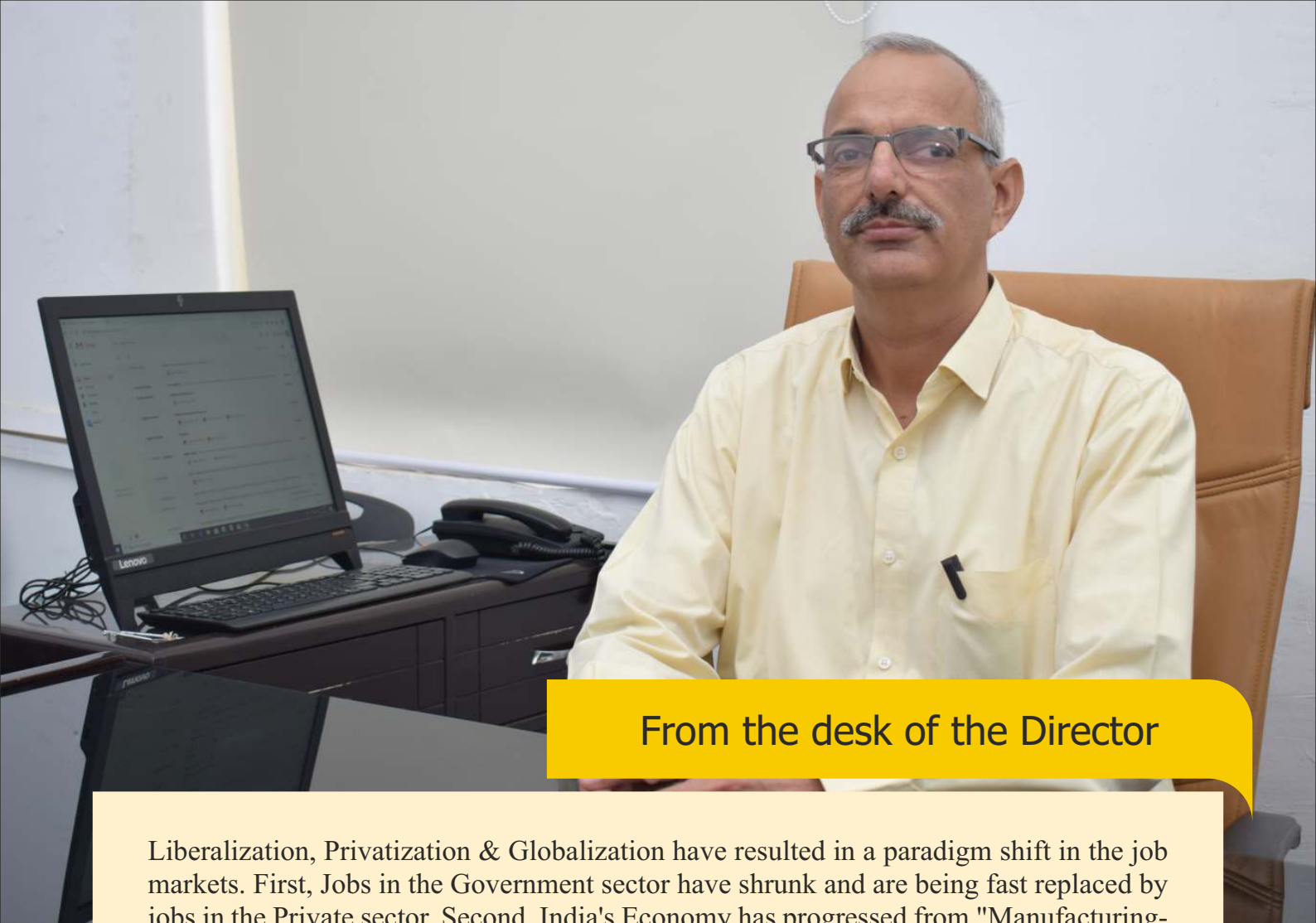


## From the desk of Director General
